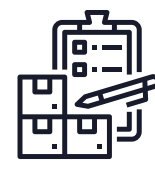
APPLICATION FOR CARGO INSURANCE

CARGO insurance **extends the scope of liability to the entire value** of the transported goods, which is not covered by Carrier's Liability based on CMR Convention.

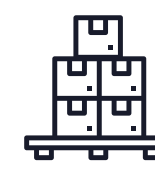

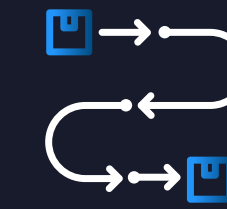

Please **let us know** that you would like to take additional cargo insurance **before transport begins**.

The **maximum value** of the goods **cannot exceed € 500 000** in the one transportation,
and **€ 1 000 000** for accumulation of shipments on a single truck.

New cars & motorbikes and medicines & pharmaceuticals has a sublimit of **€ 150 000**.

APPLICATION FOR CARGO INSURANCE

CARGO insurance requires an **additional fee**, which amount depends on the type of transported goods.

AMOUNT OF ADDITIONAL FEE (min. 100 PLN)

The indemnity paid will be 95% of the value of the damage,
as 5% of the fee is the deductible charged by the insurer.

IN PRACTICE

EXAMPLE 1



The value of the goods is € 100 000,
the fee will be € 140.

EXAMPLE 2



The value of new car is € 100 000,
the fee will be € 200.

EXAMPLE 3



The value of medicines is € 100 000,
the fee will be € 200.

APPLICATION FOR CARGO INSURANCE

Cargoes excluded from the CARGO insurance:

- cash, securities, cheques, bills of exchange, documents,
- precious stones, jewellery products, precious metals,
- antiques, works of art, artistic and unique items, collections and collections of all kinds,
- philatelic collections,
- live animals,
- organs, corpses or human remains,
- cell phones whose value per one means of transport exceeds EUR 50,000,
- drugs, psychotropic and hallucinogenic drugs,
- resettlement property and property transported as hand luggage,
- damaged or decomposed property,
- used cars and motorcycles, and used spare parts or used finished components,
- brand new cars and motorcycles the value of which exceeds EUR 150,000,
- armaments, military equipment and property and the so-called dual use property,
- oversized cargo.

It is **possible to accept for insurance** the loads mentioned in the paragraph above, provided they occur at least **1 working day** before the commencement of transport. Then the terms and amount of the fee shall be specified.
